## WAIVER & RELEASE THIS IS A RELEASE

## Waiver and Release from Liability

In consideration of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as the areas to which admission by the general public or spectators is prohibited), or being permitted to compete, officiate, observe, work for, or any purpose participate in any way in the event, EACH OF THE UNDERSIGNED, hereinafter referred to as "releaser", for himself, his personal representatives, heirs, next of kin, acknowledges, agrees, and represents that he has, or will immediately upon entering any such restricted areas, and will continuously thereafter, inspect such restricted area or areas and all portions thereof which he enters and with which he come in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that he has inspected such areas and that he finds and accepts the same as being safe and reasonably suited for the purpose of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted area(s) and further:

- 1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the "Pagnozzi Parker Charity Big Bass Tournament", the promoters, other participants, operators, officials, any persons in a restricted area, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes hereinafter referred to as "releasee", from all the undersigned, his personal representatives, assigns, heirs, and nest of kin for any and all damage, and any claim or demands therefore on account of injury to the person or property of resulting in death of the undersigned, whether caused by negligence of the "releasee" or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, or working for, or for any other purpose of participation in the event.
- 2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to presence of the undersigned in or upon the restricted area or in any way competing, officiating, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.
- 3. HÉRÉBY ASSUMES FULL RESPONSIBILITY FOR ANY REISK OF BODILY INJURY, DEATH OR PROPER-TY DAMAGE due to negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for, or for any purpose participating in the event.
- 4. EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities at the event and in the restrict-ed areas are dangerous and involved the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity is intended to be as broad and inclusive as is permitted by the low of the State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.
